Christmas Carol program

The Christmas Carol Program is entering its 51st year of extending a helping hand to deserving families over the holidays. What began as just a community project so long ago has developed into an incredible signature program that now helps those who are in need through no fault of their own throughout Central Pennsylvania. The Christmas Carol Foundation is a 501(c) (3) organization with trustees who oversee the use of the funds, which come entirely from donations. All donations are tax deductible. All time is donated. For 50 years, the Christmas Carol Foundation has helped those who have ill family members, or have suffered a devastating injury or accident. As an example, Christmas Carol could help provide that a family has monetary assistance, including but not limited to that toward obtaining warm winter clothing... toward utility bills...or other expenses such as hospital trips are fully or partially paid for. The foundation has also provided assistance to make homes handicapped-accessible...have installed new roofs ...new

furnaces and provided appliances and furniture. The foundation has provided firewood...food...and, in some cases, provided a gravestone for a deceased loved one. Children are always taken care of and, in most cases, are the focus of the Charitable Bequest.

As fall begins, so begins the search for those who are suffering the most. The Christmas Carol Foundation solicits letters from the listener nominators of the Participating Radio Station(s) and asks to be told about anyone who could use the help of Christmas Carol each year. The foundation receives letters from those concerned about friends, family members, co-workers or a church member. A panel of impartial volunteer judges from the Participating Radio Station(s) and representatives from the foundation shall serve as nomination request judges to determine the Donee Recipient(s). In their sole and final discretion, the nomination request judges impartially select 12 deserving individual/families/household unit who are thereby verified and pre-screened. Thereafter, from December 13, 2022 through Christmas Eve, December 24, 2022, one wish per day is featured on WFGY and WFBG collectively. From Christmas Day through New Year's Day, everyone who donated to the program is thanked on the air.

What happens to those who are not chosen? Local churches and community groups ask the Christmas Carol Foundation to go through the remaining letters and many are helped in that manner.
